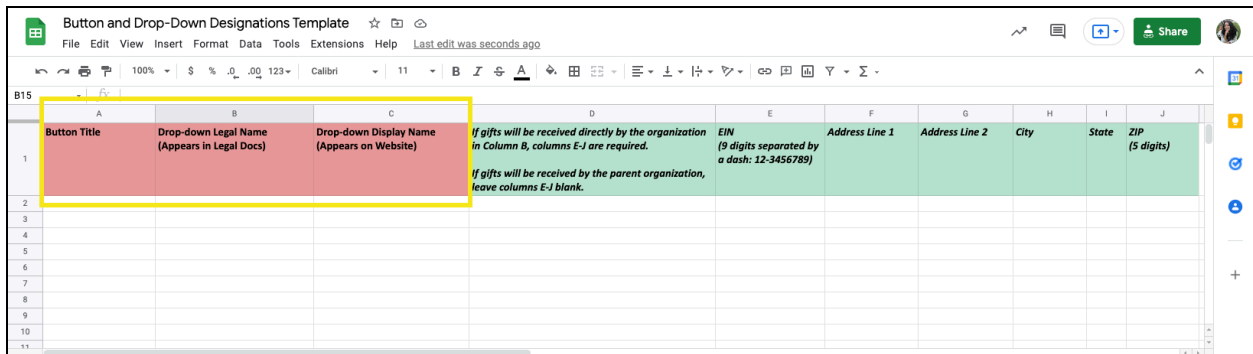


Providing Designation Options for Your FreeWill Site

Hello! As you are aware, our tools aim to make donating to your organization easy and accessible. You can provide a list of designation options (i.e. funds, programs within your organization, affiliated organizations for whom you are raising funds, etc.) to help your donors specify what they'd like their gifts to support. These designation options appear as **buttons** and **drop-downs** on your site.

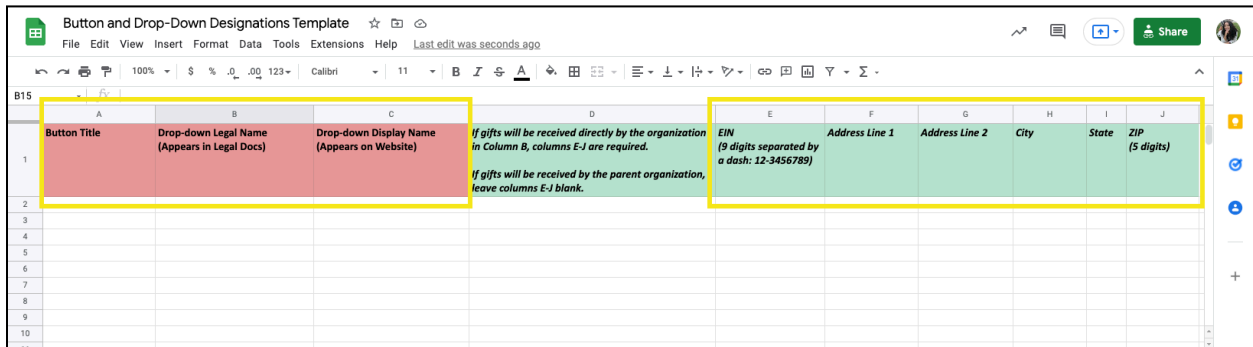

The list you provide in the template will be published on your site as submitted.

FAQs

What is a button?

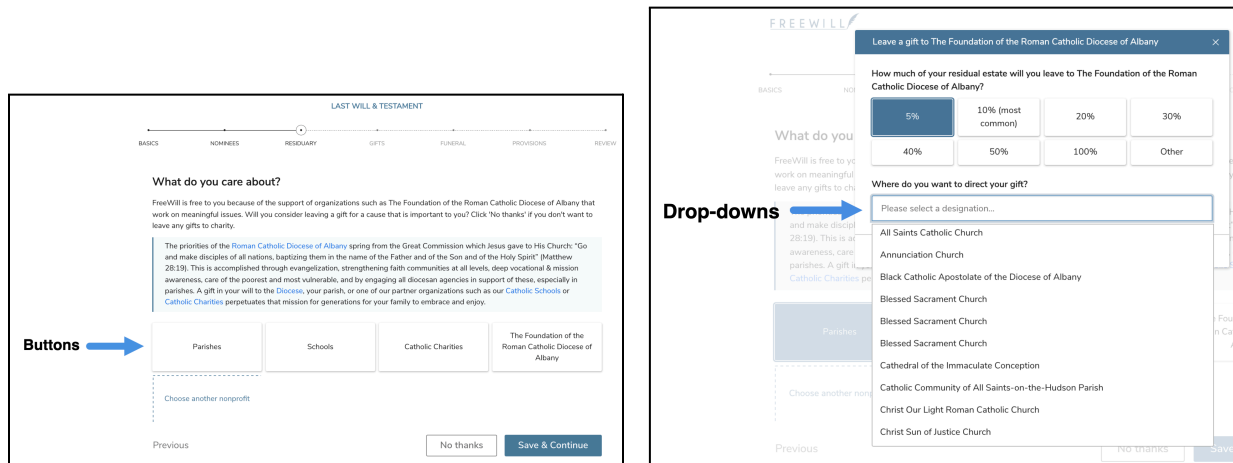
Most of our partners have one main button on their site that displays their organization's name. But you can also think of buttons as ways to group designation options. For example, if you have a list of parishes, you can create a button titled "Parishes" and show each parish as a drop-down appearing under that button.

What is a drop-down?

A drop-down is a designation option within your organization, or an affiliated organization, you'd like donors to make gifts to.

How will this information appear on my site?

The charitable giving page of your site will display buttons for your donors to click. Once a donor clicks on a button, a list of drop-downs will appear for your donor to select.

Can I control what order the buttons or dropdowns appear in?

Yes! In the template, simply list them in the order you'd like them to appear.

What will my donors' estate plans look like if gifts go to my organization directly?

If gifts will be received by your organization on behalf of an affiliated organization, donors' estate plans will include your organization's EIN and address and indicate that their gift will be distributed to your organization "in support of" the designation option they selected.

For example, if gifts will be received directly by the Brockport Foundation on behalf of specific departments or initiatives, they would list their designation options as follows:

Article V: Gift of Residue

All of the residue of my estate shall be distributed to the following beneficiaries in the noted percentages:

A. 5% shall be distributed to State University College at Brockport Foundation, Inc., a nonprofit organization, EIN 22-2143232, with an address at 350 New Campus Dr., Brockport, NY 14420, or its lawful successor, to be used in support of Area of Greatest Need; provided, however, that if the preceding instruction should become impossible to fulfill, the beneficiary may use this gift as determined by its Board of Directors (or equivalent governing body). My Executor, in my Executor's discretion, may satisfy this gift with cash or property of an equivalent fair market value as of the date of distribution.

What will my donors' estate plans look like if gifts will go to an affiliated organization directly?

If gifts will go directly to an affiliated organization, the EIN and address of the receiving organization will appear in donors' estate plans.

For example, if gifts will go directly to affiliated organizations listed by the Roman Catholic Diocese of Albany, they would list their designation options as follows:

If a donor selected the “All Saints Catholic Church” drop-down under the “Parishes” button, their estate plan would read:

Affiliated organization's information (name, EIN, address)

Article V: Gift of Residue

All of the residue of my estate shall be distributed to the following beneficiaries in the noted percentages:

A. 100% shall be distributed to All Saints Catholic Church, a nonprofit organization, EIN 27-0221761, with an address at 12 Rosemont Street, Albany, NY 12203, or its lawful successor, to be used as determined by its Board of Directors (or equivalent governing body). My Executor, in my Executor's discretion, may satisfy this gift with cash or property of an equivalent fair market value as of the date of distribution.

If all of the above dispositions in this Article V fail, I give all of the residue of my estate to my Heirs.

What information is required for customized buttons and drop-downs?

- Organization Address
- ZIP Code
 - *Must be 5 digits.*
- EIN
 - *Must be 9 digits. First 2 digits must be separated from the following 7 with a dash, e.g. 13-5613797.*
 - *EINs not formatted correctly can lead to delays in processing gifts.*
- Legal Name
 - *The organization's name printed as you want it to appear in donors' estate plans.*
- Display Name
 - *The organization's name printed as it will appear in the button or dropdown menu.*
 - *If the organization uses an acronym for its display name, we recommend providing the organization's full name AND acronym to make it as clear as possible for your supporters (e.g. American Heart Association (AHA)).*
